SANCTION ORDER

SUBJECT: Award of Senior Fellowship to Prof A K Srivastava for two years .

Dear Sir/Madam,

I have been directed to convey that Prof A K Srivastava has been awarded Senior Fellowship by the ICSSR to work on research theme entitled "Mental Status Examination of Elderly in Vindhya Region ; Incidence of Depression and Anxiety Disorders" for two years w.e.f 01/01/2019 subject to the fulfilment of the terms and conditions of the fellowships and will be governed by the Guidelines of the ICSSR Fellowships. The sanction order is being issued initially for a period of one year-w.e.f. 01/01/2019 to 31/12/2019.

1. The amount of fellowship and contingency grant for one year will be as under:

- i. Fellowship amount @ Rs.45,000/- p.m. X 12 =Rs.5,40,000/-
ii. Contingency grant @ Rs.40,000/- p.a. = Rs. 40,000/- Total: =Rs.5,80,000/-

The fellowship amount including contingency grant will be released as follows:

- i. First Instalment Rs.2,90,000/- (50% Fellowship with 50% Contingency of one year)
ii. Second instalment Rs.2,90,000/- (50% Fellowship with 50% Contingency of one year)
Rs: 5,80,000/-

2. The first instalment will be released after receiving the Grant-in-aid-Bill (GIB) in the enclosed proforma duly signed by the competent authority of the affiliating institution (affixed with revenue stamp).

3. The second instalment will be released on receipt of a satisfactory Six Monthly Progress report along with Statement of Expenditure in the enclosed proforma. The progress reports are to be duly signed by the scholar and the Statement of Expenditure is to be issued by the Affiliating Institution. These documents are to be duly signed and stamped/forwarded by the competent authority of the Affiliating Institution.

4. Extension into the second year will be communicated on receipt of the satisfactory progress report of the first year research work. In case the progress report is delayed, the fellow is required to mention the reasons for the delay.

5. The Affiliating Institution shall provide to the fellow office accommodation including furniture library and research facilities and messengerial services. For this, the ICSSR shall pay overhead charges @ 7.5% of the total expenditure incurred on the fellowship, to the public funded Affiliating Institution, after the expiry of the fellowship on submitting the audited statement of accounts including utilization certificate in form: 12A by them.

6. The contingency grant may be utilized for books, stationery, computer related costs, and the field work expenses connected with the research work.

7. All the fellowships are subject to income tax deductions, which shall be made by the Affiliating Institution.

8. The accounts and utilization certificate will be signed by the Finance Officer/Registrar/ Principal/Director in case the accounts of the Institution are audited by the CAG/AG. Otherwise, they need to be signed both by the competent authority of the affiliating institution along with a chartered accountant.

9. During the tenure of the fellowship the fellow will be treated as an employee of the University/Institution for all the administrative purposes and the rules of the university/Institution shall apply in the matter of draws of TA/DA holidays and contingency grant.
10. If a fellow leaves the fellowship before its full term, he/she has to give an undertaking to submit the final report within a reasonable period but he has to submit a detailed progress report duly forwarded by the Supervisor. In such cases, the ICSSR may consider to pay contingency grant. If the scholar leaves without completion of the work and without the entire amount already released by the ICSSR, he/she has to refund entire amount of fellowship released with penalty/penal interest. Informing the ICSSR, he/she has to refund entire amount of fellowship released with penalty/penal interest.
11. On completion of the fellowship, the scholar should submit the following:
- A book-length final Report in a publishable form along-with an Executive Summary of the report (up to 5000 words) and research papers published.
 - These documents should be submitted in hard copy (two copies of final report and three copies each of the Executive Summary and research papers) and a soft copy of these documents in a pen-drive.
 - A certificate of settlement of assets and books purchased out of the fellowship grant issued by the affiliating Institution.
12. A maximum of three months period can be granted for submission of the final report after completion of the fellowship.
13. The amount of grant sanctioned herein is to be utilized by stipulated period. Any amount of the grant remaining unspent during this period shall be refunded to the ICSSR immediately after completion of the project.
14. If it appears to the ICSSR at any point of time that the progress or conduct of the fellow has not been satisfactory, his/her fellowship may be suspended or terminated forthwith.
15. The fellow shall work on a whole-time basis and, therefore, while accepting fellowship from the ICSSR, a fellow should not accept any other fellowship or research project or regular financial benefit/assignment from any other institution.
16. If the grantee fails to utilize the grant for the purpose for which the same has been sanctioned or leaves the fellowship before completion of the tenure of fellowship to take up any other assignment/job or any other reason, the scholar shall have to refund the entire amount of the grant received upto the date of leaving the fellowship with interest thereon @10% per annum from date of its sanction. Or shall undertake to submit the final report without claiming the fellowship from the ICSSR from the date of joining of the other assignment/job. In such cases even the sum against contingency shall be provided only for the period of fellowship availed.
17. Other terms and conditions mentioned in the fellowship guidelines shall apply.

I am pleased to inform you that after due process of expert evaluation of your application and on the recommendations of the MHRD- Empowered Committee, University Grants Commission has selected you as the UGC-Dr. D. S. Kothari Post Doctoral Fellow (DSKPDF). The postdoctoral Fellowship (PDF) is tenable for a period upto 3 years for full time research in the chosen area as accepted by your Mentor Prof. Prof. Adya Prasad Mishra ,Department of Physics Awadhesh Pratap Singh University Rewa-468003, Madhya Pradesh.

1. The awardee shall have to join the department and the mentor as early as possible but not later than a period of 3 months from the date of issue of this award letter.

2. The maximum duration of the PDF award is 3 years, the fellowship is awarded on yearly basis with renewal/termination clause, on the basis of appraisal of the DSKPDF's mentor/expert.

3. It may be noted that UGC has developed a dedicated web-portal (<https://scholarship.canarabank.in/AdminLogin.aspx>) for capturing data of the awardee. The Universities/Colleges/Institutions will submit the master data of the awardee on the portal with a unique user's profile of the University/Institution (user name and password already provided to the University/Institution). The University/Institutions shall submit & update the information in the master data (regarding continuation, HRA and resignation etc.) of the beneficiaries quarterly basis after verifying the progress of the fellow. In case concerned University/Institution has not registered on the web portal (<https://scholarship.canarabank.in/AdminLogin.aspx>), they may do so now. Based on the master data submitted on the web portal by the concerned Universities/Institutions the payment of the fellowship will be made into individual beneficiary account.

4. The PDF award will carry a contingency grant of Rs. 1,00,000/- p.a. The Fellow is expected to utilize the grant with the approval of Mentor and as per the rules of University/Institution.

5. The Fellowship and contingency amount will be transferred electronically through Direct Benefit Transfer (DBT) scheme. The awardee should submit the Joining Report to the University, in the prescribed format (as per Certificate-I), along with the Award letter to the University, duly signed by the Head of the Department of the University and must forwarded by the Registrar.

6. At the end of every three months the awardee has to submit continuation certificate in the prescribed format (as per Certificate-II) to the University/Institution in order to become eligible to draw fellowship for the next three months. The awardee has to submit the HRA certificate in

the prescribed format (as per **Certificate-IV**) to the University to avail the House Rent Allowance. The HRA certificate has to be submitted after every three months.

7. After the end of each year the awardee has to submit utilization certificate of contingency grant in the prescribed format (as per **Certificate-III**) to the University/Institution. In addition, the awardee shall submit Annual Progress Report in the prescribed format (as per **Certificate-V**) through the respective Mentor with a certificate of satisfactory performance from the date of commencement of the project, to the University/Institution in order to be eligible to get fellowship for the next year.

8. It is mandatory to submit the utilization certificate and Annual Progress Report within 30 days from the end of each year. The Awardee shall also submit electronically Annual Progress Report (as per **Certificate-V**) of the research work through the respective Mentor with a certificate of satisfactory performance from the date of commencement of the Project, to National Co-ordinator of UGC- Dr. D. S. Kothari Postdoctoral Fellowship Scheme at dskpdf@unipune.ac.in with a subject title Annual Progress Report. In case, the research work is found unsatisfactory, the award is liable to be discontinued.


9. The UGC may terminate the fellowship for the awardee in any of the following cases under the advice of the DSKPDF Cell.





SANCTION ORDER

SUBJECT: Award of Senior Fellowship to Prof A K Srivastava for two years .

Dear Sir/Madam,

I have been directed to convey that Prof A K Srivastava has been awarded Senior Fellowship by the ICSSR to work on research theme entitled "Mental Status Examination of Elderly in Vindhya Region : Incidence of Depression and Anxiety Disorders" for two years w.e.f 01/01/2019 subject to the fulfilment of the terms and conditions of the fellowships and will be governed by the Guidelines of the ICSSR Fellowships. The sanction order is being issued initially for a period of one year w.e.f. 01/01/2019 to 31/12/2019.

1. The amount of fellowship and contingency grant for one year will be as under:

i.	Fellowship amount @ Rs.45,000/- p.m. X 12	=Rs.5,40,000/-	
ii.	Contingency grant @ Rs.40,000/- p.a.	= Rs. 40,000/-	Total: =Rs.5,80,000/-

The fellowship amount including contingency grant will be released as follows:

2. The first instalment will be released after receiving the Grant-in-aid-Bill (GIB) in the enclosed proforma duly signed by the competent authority of the affiliating institution (affixed with revenue stamp).

3. The second instalment will be released on receipt of a satisfactory Six Monthly Progress report along with Statement of Expenditure in the enclosed proforma. The progress reports are to be duly signed by the scholar and the Statement of Expenditure is to be issued by the Affiliating Institution. These documents are to be duly signed and stamped/forwarded by the competent authority of the Affiliating Institution.

4. Extension into the second year will be communicated on receipt of the satisfactory progress report of the first year research work. In case the progress report is delayed, the fellow is required to mention the reasons for the delay.

5. The Affiliating Institution shall provide to the fellow office accommodation including furniture library and research facilities and messengerial services. For this, the ICSSR shall pay overhead charges @ 7.5% of the total expenditure incurred on the fellowship, to the public funded Affiliating Institution, after the expiry of the fellowship on submitting the audited statement of accounts including utilization certificate in Form 12A by them.

6. The contingency grant may be utilized for books, stationery, computer related costs, and the field work expenses connected with the research work.


7. All the fellowships are subject to income tax deductions, which shall be made by the Affiliating Institution.


8. The accounts and utilization certificate will be signed by the Finance Officer/Registrar/ Principal/Director in case the accounts of the Institution are audited by the CAG/AG. Otherwise, they need to be signed both by the competent authority of the affiliating Institution along with a chartered accountant.

9. During the tenure of the fellowship the fellow will be treated as an employee of the University/institution for all the administrative purposes and the rules of the university/ institution shall apply in the matter of draws of TA/DA holidays and contingency grant.
10. If a fellow leaves the fellowship before its full term, he/she has to give an undertaking to submit the final report within a reasonable period but he has to submit a detailed progress report duly forwarded by the Supervisor. In such cases, the ICSSR may consider to pay contingency grant. If the scholar leaves without completion of the work and without the entire amount already released by the ICSSR. If the scholar leaves without completion of the work and without informing the ICSSR, he/she has to refund entire amount of fellowship released with penalty/penal interest.
11. On completion of the fellowship, the scholar should submit the following:
- A book-length final Report in a publishable form along with an Executive Summary of the report (up to 5000 words) and research papers published.
 - These documents should be submitted in hard copy (two copies of final report and three copies each of the Executive Summary and research papers) and a soft copy of these documents in a pen-drive.
 - A certificate of settlement of assets and books purchased out of the fellowship grant issued by the affiliating Institution.
12. A maximum of three months period can be granted for submission of the final report after completion of the fellowship.
13. The amount of grant sanctioned herein is to be utilized by stipulated period. Any amount of the grant remaining unspent during this period shall be refunded to the ICSSR immediately after completion of the project.
14. If it appears to the ICSSR at any point of time that the progress or conduct of the fellow has not been satisfactory, his/her fellowship may be suspended or terminated forthwith.
15. The fellow shall work on a whole-time basis and, therefore, while accepting fellowship from the ICSSR, a fellow should not accept any other fellowship or research project or regular financial benefit/assignment from any other institution.
16. If the grantee fails to utilize the grant for the purpose for which the same has been sanctioned or leaves the fellowship before completion of the tenure of fellowship to take up any other assignment/job or any other reason, the scholar shall have to refund the entire amount of the grant received upto the date of leaving the fellowship with interest thereon @10% per annum from date of its sanction. Or shall undertake to submit the final report without claiming the fellowship from the ICSSR from the date of joining of the other assignment/job. In such cases even the sum against contingency shall be provided only for the period of fellowship availed.
17. Other terms and conditions mentioned in the fellowship guidelines shall apply.
